Meeting Minutes

Time: 09:00 – 12:00

1. Welcome, Attendance and Apologies/Proxies

The Chair, Ron Brent, opened the meeting at 9:00am and welcomed members and observers to the March 2023 CACG meeting. The Chair acknowledged the traditional Custodians of the cultural landscape on which Gold Coast Airport is situated, the Yugambeh and Bundjalung people, and paid respect to their elders, past, present and future.

2. Consideration of Previous Minutes/Action List

2.1 CACG Thursday 24 November meeting minutes

Lindy noted that an updated copy of the November minutes was to be sent out to the committee for endorsement. Secretariat to distribute immediately after meeting. Members were asked to provide any comments out of session.

2.2 Action List & Recommendations

2.3 Membership Updates

No new memberships or resignations to advise.

Airservices Report

9:23am John Graham, Community Engagement Advisor from AirServices introduced the AsA representatives, Sarah Tittmann, Scott Stephens, Glenn Cox, Stephen Tapsell and Neil Bain.

Refer to presentation - Attachment 3 for full details on the Airservices report.

ACTION: Noise Monitor Review - John Graham to see if it is possible to provide the full report on noise monitoring sites.

Issues:

- Is the Pyramid Holiday Park noise monitor at the front or the back of the park given that there is ambient noise at the front?
- Members are concerned about the locations that have been selected for the noise monitors.
- Members noted that the 2015 review stated that the monitor is to remain in its current location.

ACTION: Airservices to confirm the exact location of the noise monitor at the Pyramid Park site.

 John advised that the Southern Operations Review is currently with Airservices which will include the response to feedback in the final report.

Lindy Smith advised that there are a number of movements that have been incorrectly logged on Webtrak. The advice provided by the Ombudsman stated that tracks can have a discrepancy of up to 250m, however some of the Webtrak data is showing inaccuracies in excess of 1km. The Chair advised that this matter is best to be kept on the ANACC agenda under Action Item 91, although the response will be closely monitored by the CACG.

In response to questions:

 John Graham advised that operators prefer to use the AR on the northern approach as it is a shorter approach.

DSI Update

9:50am - Sarah Tittmann – Community Engagement Advisor spoke to the committee about the Airservices' National PFAS Management Program. Sarah introduced Stephen Tapsell who has recently joined the PFAS team as the Community Engagement Leading Specialist.

- Sarah advised members to register on the <u>NATIONAL PFAS MANAGEMENT PROGRAM</u> web page to receive progress updates.
- o Milestone 1 Project Commencement by Apr 2023.
- Milestone 2 SAQP (Sampling Analysis Quality Plan) Implementation from May 2023.
 Field-work will take plan with sampling for 6-8 weeks.
- Milestone 3 Report Writing from August 2023.
- Milestone 4 Implementation estimated April 2024.

In response to questions:

- Sarah Titman provided the following additional information:
- Both the Department of Environment and Science for QLD and EPA for NSW are provided with the PFAS reporting. There are also two independent auditors who will review what is being done given the unique geographical location of the airport running across two states.
- Weather conditions can, at times, delay the sampling program.
- The methodology around the sampling doesn't directly take into consideration seasonality but the assessment also uses other sampling that has been taken at different times of the year, including historical data. This provides insights into seasonality. There are sites being sampling during the first and second week of April. GCA have also been conducting sampling which assists in assessing seasonality.
- The Sampling Analysis Quality Plan will not be a public document, and will not be distributed. Any concerns around the SAQP should be fed back into the process via the regulators, Qld DES and NSW EPA. The feedback that has been provided has been noted.
- The members noted that they are disappointed that we are still only at the beginning of the DSI given that the issue has been a priority since 2008.

- Lindy Smith thanked Airservices/GHD for the PFAS extra-ordinary meeting but advised that the minutes did not record some significant matters and asked when the minutes were to be updated?
 - Sarah Tittmann advised that she would follow up to ensure that the minutes are amended as required to make them accurate.
 - Lindy Smith reiterated her concern that the two primary discharge points into the Cobaki Broadwater have not been sampled, noting that existing contour and flow mapping demonstrates a high risk of contamination.

ACTION: Airservices to update the PFAS extraordinary minutes as required to ensure their accuracy.

ACTION: Airservices to follow up on why the two primary discharge points (migration pathways) to the Cobaki Broadwater are not included in the DSI. The first point is the drainage network west of the runway, the second point is the overflow of the Coolangatta Creek.

- Cr Gail O'Neill advised that City of Gold Coast has done some initial testing at Coolangatta
 Creek which would be useful for the DSI, should they wish to access this information.
 - Sarah Tittman advised that GHD/Airservices have been in contact with the Council and will continue that engagement, and thanked Councillor O'Neill for passing this on.

In response to further questions Sarah Tittmann also advised that:

- o There is a funding commitment to act on the outcome of the DSI once this has been finalised.
- There is no specific document that sets out the funding as this can only be determined once the DSI has been finalised.

The meeting asked that the minute's note explicitly that we have known about contamination for many years but as yet there has been no remediation.

In response to a related but separate issue, Norbert Benton advised that there had been no decision to change the name of Coolangatta Creek and the Master Plan uses this name although there are other references to it in different terms. In future every effort will be made to ensure its correct name is used instead of referring to 'Drainage Reserve'.

Jacqui Cord asked if the latest results of the Coolangatta Creek sampling by City of Gold Coast Council are available? Cr Gail O'Neill advised that she doesn't think they are available to the public. She noted that there are two signs warning people not to swim, although people still continue to swim there.

4. Gold Coast Airport update

10:30am - Abigail Koch - GCA Strategic Communications General Manager, provided an update on latest events and news at Gold Coast Airport.

Refer to Attachment 4 for full details.

Abigail Koch drew particular attention to the power outage in February and assured the CACG that the GCA team was able to resolve this issue immediately and that they are trained to handle situations such as these.

Key points from the discussion of the report were:

- David Gray the positioning of the Light and Heavy Rail stations is inappropriate. This is going to create a lot of issues particularly for the elderly and people with disabilities as the distance to the terminal is too far.
- John Hicks asked if GCA will consider travelators?
 - Liam Campbell responded to say they will look to explore the idea of more connections and better wayfinding.
- Julie Murray noted that there needs to be provisions to assist people with limited mobility (walkers, wheelchairs etc).

5. Pacific Airshow Presentation

11:00am – Bree Andrews and Ken Ashmore gave a presentation on the upcoming Pacific Airshow scheduled to take place from the 18-20 August 2023. Members appreciated the detailed briefing.

Refer to Attachment 5 for full details.

ACTION: Pacific Airshow to share the aircraft schedule with the CACG committee.

6. Emergent Issues

- John Sweeney asked whether the work being carried out on the Tugun Bypass Tunnel is related to cancer.
 - o Matt Bender to take this on notice with the projects team.
 - Community raised concerns given previous issues with the M1 tunnel and the proposed heavy rail.
- Bill Pinkstone expressed his concern about the tower hours and the extent to which the tower was unstaffed.
 - Neil Bain advised that there was a plan in place to build hours back up, but that there are currently staffing challenges. The very extensive training required to qualify additional Air Traffic Controllers means that it can take considerable time to replace staff, which meant unexpected increases in staff turnover will limit the capacity to increase tower hours in the short term.
 - Neil Bain will provide regular updates and advise of milestones reached as part of AirServices updates to the CACG.
- John Hicks thanked GCA for the masterplan workshop, and raised his earlier question about usage data for AirTrain and public transport to the airport.
 - Abigail Koch advised that AirTrain would not provide passenger information and Kinetic will look into what information they can release about the 999 service, although as yet nothing has been received.
- John Hicks wanted clarification as to whether the minutes uploaded on to the CACG website were to include the last 5 years, but noted that he would be satisfied if recent and current minutes were uploaded provided they included full information, such as the agenda, material correspondence, and presentations.
- John Sweeney noted that the GCA ticket machines provided tickets that were faint and hard to read querying whether they required more ink?
- Julie Murray advised that when considering handrails for travelators/infrastructure around the
 airport, that they need to extend beyond the end of the moving section to allow passengers
 enough time to stabilise when stepping off the device.
- Lindy Smith asked that the Master Plan figures on noise contours and particularly the ANEF should refer back to the 2010 and 2020 Master Plans in order to provide better information about the changes in the contours.

- Lindy Smith asked what measures have been developed to monitor biosecurity for flights from Bali to the Gold Coast?
- David Gray requested that all matters relating to Airservices and PFAS provided between meetings should be provided direct to the Chair/Secretariat and then circulated to all members.

ACTION: Matt will advise on whether the issues with the tunnel involve concrete cancer.

ACTION: Airservices to provide an update on the tower operating hours and resourcing at each meeting.

ACTION: Secretariat to review the packaged minute files and the series of minutes to include on the website.

ACTION: The airport update at the next meeting will include advice on biosecurity measures for direct flights from Bali.

ACTION: Airservices will provide any urgent updates sent out between meetings (including particularly on PFAS) directly to the Chair/Secretariat for distribution.

7. AFP update

- There has been substantial planning for the Pacific Airshow.
- There are continuing efforts to support and maintain the Airport Watch Program which is a valuable program to uphold national security.
- AFP monitors aircraft operations outside curfew hours.

8. General Items

- Air Quality Program is to be an agenda item for the next meeting in July.
- The Chair raised the idea of merging the ANACC and the CACG to avoid the overlap. This could include an increase to four instead of three meetings in a year and have each meeting run slightly longer (but with a proper break) to ensure enough time to cover off agenda items. The Chair asked that members consider this issue so that it might be discussed at the next meeting.

ACTION: The Department to provide a briefing on the aviation white paper and the curfew process.

ACTION: Air Quality and the future of the separation of the ANACC and CACG be agenda items at the next meeting.




NCIS UPDATE 2022 YEAR IN REVIEW - COMPLAINANTS PER MONTH






NCIS UPDATE 2022 YEAR IN REVIEW - COMPLAINANTS PER YEAR




NCIS UPDATE 2022 YEAR IN REVIEW - SUBURBS






NCIS UPDATE 2022 YEAR IN REVIEW - ISSUES




Light Rail – Airport Concept

Event production became common thread to many of his services and five years ago Elliott added Pacific Airshow to his company's portfolio.

Elliott brought Code Four's resources to help the show's ground game in 2017 and took over the show in 2018. His vision of a lifestyle festival with an airshow component is unfolding with new additions to each show. In his first year at the helm, the U.S. Air Force named Pacific Airshow as the Civilian Show Site of the Year. This honor demonstrates the commitment of not only Code Four and Elliott but all of those who work together to make Pacific Airshow a global destination event. The U.S. Air Force honored Pacific Airshow a second time with this award, the only airshow in the country to achieve this.

In 2021, Elliott was appointed to multiple board seats, including the International Council of Airshows (ICAS) Board of Directors, the Los Angeles Sports Council, and Southern California Committee for the Olympic Games.









Community Aviation Consultation Group (CACG) Code of Conduct

This Code of Conduct outlines rules and responsibilities for all members of the Gold Coast Airport Community Aviation Consultation Group (CACG) community forums. It should be read in conjunction with the Terms of Reference, which outline the purpose, composition and function of the group.

By participating in the Gold Coast Airport CACG members acknowledge that they will abide by the Code of Conduct before participating in any related activities.

As a member of the Gold Coast Airport CACG, I agree to:

- Notify the Chair of any potential conflict of interest that may arise.
- Attend CACG meetings or provide an apology in advance if I can't attend. I understand it is expected that, unless there are exceptional circumstances, members will not miss more than one meeting in a row and will attend three out of every four meetings on a rolling basis.
- To the best of my ability, share authorised information with the people/community I represent; and provide insight and feedback on their views on Gold Coast Airport planning and operations.
- To the best of my ability, obtain and represent the views of the broader community even if they are different from my own.
- Be open and available to community members who wish to provide their thoughts and comments on Gold Coast Airport planning and operations.
- Participate in a positive way to find solutions to issues or concerns.
- Approach meetings with a positive, respectful and constructive attitude.
- Respect the ideas and beliefs of CACG members and invited guests.
- Contribute to an atmosphere where all members feel comfortable participating.
- Maintain confidentiality of information provided at CACG meetings or via the CACG email that is specifically mentioned or marked as confidential.
- Not speak on behalf of or claim to represent the CACG without prior written approval from the Chair.
- Not speak to the media as a CACG representative without prior written approval from the Chair.

I understand that if I breach the Code of Conduct, the Independent Chair may ask me to step down.

Terms of Reference

1. Context

This document is based on the CACG Guidelines (2016) published by the (then) Department of Infrastructure and Regional Development (insert hyperlink).

2. Purpose

The purpose of the Gold Coast Community Aviation Consultation Group (CACG) is:

- to enable airport operators, residents affected by airport operations, local authorities, airport users, Airservices Australia and other interested parties to exchange information on issues relating to airport operations and their impacts
- to allow matters to be raised and taken into account by the airport operator and Airservices Australia, with a genuine desire to resolve issues that may emerge
- to complement and support the consultative requirements already established for Master Plans and Major Development Plans (MDPs)
- to discuss and share information between the airport and the communities affected by its operations and plans.

The CACG representation will include representatives from local authorities, airport users and other interested parties.

The CACG will foster inclusion, collaboration, empowerment, and transparency in decision-making, allowing the concerns of interested parties to be raised and taken into account.

Reports will also be provided to the CACG from government departments including the Department of Infrastructure, Transport, Regional Development and Communications, Airservices Australia and the Civil Aviation Safety Authority (CASA) as and when required.

2. Chairperson

The role of the Chair is to:

- Ensure the input of the full membership is sought as to agenda items
- Ensure adequate discussion time is devoted to issues of significance
- Allow for discussion of unanticipated 'other business' at CACG meetings
- Ensure agenda materials and papers are meaningful and facilitate effective engagement of members in CACG discussions





- Encourage open discussion and frank exchange of views
- Monitor effective follow-up of action items.

The Chair will disclose any interests, arrangements or associations to CACG, which may be perceived as a conflict of interest.

3. Secretariat Role

The role of the Gold Coast Airport will be to provide the secretariat position on the CACG, as well as provide administrative support for the Chairman. The secretary will be a suitably qualified Gold Coast Airport staff member. GCAPL will publish the outcomes of meetings on a designated CACG website.

The role of the secretariat is to:

- Communicate arrangements made for CACG, including any framework documents, such as procedural arrangements and terms of reference, to the members;
- Prepare, distribute and publish records of CACG meetings;
- Prepare and distribute meeting agendas;
- Ensure that CACG members are notified of meetings and given an opportunity to prepare for the meetings;
- Support the activities of the Chair as required;
- Coordinate input to assist CACG on policy, technical and other support issues, where agreed;
- Provide details on the CACG's work for the purpose of consideration as part of the airport's annual lease review.

4. Role of Airport Management

GCAPL Management will offer items for the agenda, attend meetings and provide relevant information on airport developments and operations.

GCAPL Management will give serious consideration to recommendations made by the GCA CACG, particularly in relation to Master Plans and MDPs.

5. Meetings

CACG will meet three times per year.

The CACG will endeavour to keep a contemporary agenda that captures the key issues of interest to the community and provide a structured approach to keeping the community informed of these issues A draft agenda will be circulated to all members one month prior to the meeting date (or such shorter period as agreed by the Chair following consultation with members) to facilitate member input and comment.

CACG Members are to provide the Chairperson with information on and/or action taken on outcomes from a meeting at least ten (10) working days before the next CACG meeting.





6. Membership

Membership of CACG is via invitation only to community groups affected by airport operations, airport users, airport operators, local authorities and interested parties representing the community or industry on the Gold Coast and northern New South Wales.

GCAPL will invite representatives from government (Federal, Local, State), tourism and business, and the general community to participate in CACG.

The Chairperson may invite other persons on an ad hoc basis to address CACG on particular agenda items.

Each member of CACG is responsible for ensuring that progress and other achievements of the CACG are communicated effectively to the organisation or group that the individual represents.

Each member of CACG is responsible for ensuring that updates on issues raised by the organisation or group that the individual represents are communicated effectively to the Group.

6.1. Role of ANACC within CACG

The Aviation Noise Abatement Consultative Committee (ANACC) is as a technical sub-committee of CACG.

ANACC will provide technical, operational and other advice to assist CACG to communicate accurate and relevant technical information and to help consider ways to improve long-term noise mitigation measures.

ANACC members will represent the Aviation Noise Abatement Consultative Committee on the CACG.

7. Appointments

Appointments will be for an initial period of three (3) years, commencing at the first meeting and will be subject to renewal at the end of that period, unless determined at an earlier date by agreement.

8. Scope of Powers

CACG is for consultation purposes only and is neither an arbitration nor a decision-making body and discussion at CACG meetings should not be allowed to be dominated by a single topic or individual member.

CACG will focus on current activities and future developments and will not revisit past decisions.

9. Proxies

A proxy is a stand-in for a representative member unable to attend and shall fulfill the function ordinarily incumbent to the absent Member.

10. Communication of CACG Activity and Outcomes

GCAPL will provide information on the CACG through its website: (cacg.goldcoastairport.com.au). This will include publication of all CACG meeting minutes for the past five years.





GCAPL and the Chairperson (as appropriate) will make any official comment on the conduct and outcomes of CACG.

The CACG will establish strategies to inform the broader community of major issues as required.

11. Funding CACG

CACG will be funded by GCAPL.

12. Review of TOR

CACG TOR will be reviewed by GCAPL every three years in line with the Chairperson's appointment and whenever significant changes are made to the CACG Guidelines by the Department necessitate an update.
