

# Airport Noise Abatement Consultative Committee (ANACC)



## MEETING MINUTES

**Date:** Thursday, 15 June 2023  
**Time:** 09:00 – 12:00pm  
**Location:** Rydges Hotel, Gold Coast Airport | Teams Meeting

### 1. Welcome, Attendance and Apologies/Proxies

Chair, Matthew Bender, opened the meeting at 09:09am and welcomed members and observers to the June meeting. Chair acknowledged the traditional owners of the lands on which we were meeting, and on the attendees' behalf, paid respects to the elders' past, present and emerging.

### 2. Consideration of Previous Minutes/Action List

#### 2.1. ANACC Meeting held 23 February 2023

Chair sought feedback from members on the minutes from the 23 February 2023 meeting.

- Jann Stuckey provided feedback on a typo and an incorrect year.
- Jann Stuckey also checked that her question from the last committee meeting was interpreted correctly.

### 3. Material Correspondence

- Correspondence from the last quarter was presented. Chair advised that the majority of correspondence was related to noise and flight path and the weather conditions for the runway choice.

### 4. Airservices Update

9:43am – John Graham provided an update from Airservices for the last quarter and confirmed the Airservices representatives online, Bruce Dowdall and Niomi Arthur.

### **Noise Monitor Update**

- Final location is being installed at Palm Village week commencing 18 June 2023 and will be there for 3 months.
- Data to be accessed to determine final location for the permanent noise monitor.

### **RWY 14 ILS Star**

- Internal CEPs under review, engagement to start shortly.

### **RRO**

“RPT to use RWY 14 for arrivals and RWY 32 for departures where operationally possible, to be trialled between 10pm and 11pm during daylight savings”

- For a trial:
- Environmental assessment (internal)
- Community consultation
- Industry consultation

### **Community Engagement Standard**

- Airservices gave an overview of the standards and provided a reminder about the in-person sessions and webinars for those that wish to join online.
- All the information will be available on the AsA website.
- The committee was disappointed that the location for the CES is in an area that is not affected by aircraft noise and would like this feedback passed on to Airservices and to consider future community engagement meetings to be held in Tweed.
- Jann Stuckey asked what the timeline dissemination process was likely to be once the community engagement meeting has taken place.
  - Airservices advised that the final CES would be published in July/August 2023.
- John Graham gave an overview of the three levels of change as part of the Community Engagement Standard meetings that are scheduled to take place in June.

#### ***Questions:***

- Bill asked how the changes to the standard came about? Airservices advised that it came about internally from Airservices as there were areas where they could see improvements.
- Airservices advised that the Webtrak issues Lindy raised were correct and were put down to an e-feed issue relating to algorithms which contributed to the delay. Lindy thanked John for taking the time to investigate this further and provide answers to an issue that has been on-going for the last 6 years. John reiterated that in the future if there are any aircraft that aren't appearing to send through the date and time to the ANACC/John at Airservices to allow him to look into this further.
- Committee discussed the military activity that has been conducted over the last week and gained further clarity of the reasons for these movements such as Missed Approach training.
- Lindy brought up the incorrect reference by Airservices to the tower hours at GCA that was published in the Tweed Daily News article and that it was unacceptable. John Graham acknowledged an internal communication error resulted in incorrect tower operating hours being detailed in the story.
  - Bill asked if there will be a retraction. John to follow up and ask team.

**ACTION: John to follow up with Airservices as to whether there will be a retraction with regards to the incorrect information that was printed in the Tweed Daily News about the tower hours at GCA.**

## 5. GCA Update

10:30am – Jared Feehely gave a GCA operations update.

- Gold Coast Airport & Skytrax award achievements
  - Voted Best Regional Airport in Australia and Pacific for the fifth time.
  - Voted Cleanest Airport in Australia and Pacific for 2023.
- Ambassador program
  - There are 7 new volunteers to join the Ambassador program.
  - Expanding the Ambassadors reach in the terminal moving into ECP and SEA along with on Level 02 International Departures.
  - GCA is working hard to expand the AmbassaPAW therapy dog program to have a therapy dog in the terminal each day. Currently we have Gary and Quincy in the terminal two days a week.
- STE has been operating well. We have now also successfully implemented swing functionality into the terminal operation.
- Virgin commenced its Bali service on 29 March and Air Asia X re-commenced on 01 April.
- GCA held a plane-spotters event on Saturday 10 June 2023. Thirteen lucky competition winners had the opportunity to spot from the Foxtrot run-up bay for a few hours.
- PAX numbers are slightly lower than forecasted due to cost-of-living pressures.
- The domestic terminal is currently being renovated to bring it into line with the new STE.

## 6. Curfew Report

- Chair responded to Bill Pinkstone's question in relation to business jets and advised the Department cannot categorise "business jets" to a higher level of detail as the intent of each movement is not known.
- Chair did advise that he will approach Platinum to pass on Bill's concern and the private jet flights that are occurring outside of curfew hours.

**ACTION: Chair to approach Platinum to regarding Bill's concern over the numbers of business jets that are operating outside of curfew hours.**

## 7. GA Update

11:10am - Peter Long was unable to attend but did provide the Chair with an update:

- March and April were quieter than usual for the GA due to inclement weather.
- The month of May has seen an increase in GA traffic primarily due to the fine weather.
- Night circuits have increased, however as it is now winter the night circuits start earlier and finish earlier.
- The local flying schools are conducting more day training at other nearby airfields such as Murwillumbah, Warwick and Lismore.
- No GA noise issues have been brought to the attention of the GA from around the GCA area.
- There have been some noise complaints around the Wooyung, (north of Ocean Shores) which are being dealt with directly with the complainant. This area is impacted by noise as in the local training area.
- Winter is traditionally finer weather so an increase in GA activity expected over the seasonally wetter late summer/autumn period.

## 8. Emergent Issues

- Julie Murray is concerned about the airstrip that is being proposed 10km out of Murwillumbah and how it will affect the Northern Rivers community and the airspace accessibility to Kingscliff Hospital.
- The airstrip application was made by Farm & Co based at 529 Cudgen Road, Cudgen.

**ACTION: Chair will investigate the application further with Tweed Shire Council and update the committee.**

## 9. General Business

- Chair discussed the amalgamation of the ANACC and the CACG meetings which will benefit the committee with a better attendance of key stakeholders such as government and airline representatives and will reduce the duplication of information across both committees.
- Jann Stuckey asked if the Terms of Reference and Code of Conduct would be updated.
  - Abigail advised that the CofC would remain the same, but the ToR would need to be updated.
  - Bill Pinkstone expressed his concern that some of the government agencies may decide to leave early due to time restraints.

## 10. Pacific Airshow Update

- Chair provided an update regarding the Pacific Airshow which is taking place 18-20 August 2023.
- Discussed the aircrafts that will be parked at GCA.
- Jann Stuckey expressed her concern about helicopters hovering over resident's backyards.
- Bill Pinkstone asked if permits are removed, which the Chair responded to say they are exempt as it is a military operation.
- Chair confirmed that the any associated aircraft operations (proposed Mustang Joy Flights) will be between 9am – 5pm only or at a time deemed appropriate from a community noise impact perspective.
- Airservices are also working with CASA to confirm that there will be minimal impact on RPT commercial services during this period.

The Chair thanked members for their participation and closed the meeting at 12:11pm.

- Airservices Australia has community obligations when planning and implementing changes to flight paths. These include:
  - minimise the impact of aircraft operations on communities
  - undertake effective community engagement
  - inform the community of the development and implementation of significant changes to air navigation.
- To fulfill to these obligations and ensure best-practice community engagement on flight path and airspace changes, Airservices Australia is developing a new national Community Engagement Standard.
