#### Opening and Welcome

Meeting opened at 9:15am

Round table introductions of all in attendance.

RP provided an update on airport activities, explaining that Gold Coast Airport had the second busiest month on record, in terms of passenger numbers, in July 2009, this was on the back of the Global financial crisis, swine flu and the cancellation of several flights to Japan.

#### Terminal redevelopment

 Terminal redevelopment is progressing well and within projected timeframes with completion set for December 2009.

## Runway Overlay

 Commencement of the runway overlay project has been delayed due to supply issues and the weather. RP further highlighted that project works, once commenced, will be predominantly night works and during curfew hours. RP will keep the committee informed of tender approval and the commencement date.

#### Airlines

 Flights will increase over the coming months with the introduction of several new flights including a possible Hobart service and commencement of Air North services. Jetstar will also be bouncing back with their international flights.

  community search, as we must have 5 distinct areas with representation to the south, so the status quo can remain.
  John Sweeny has been the long standing representative for the Bilambil area, and until GCA can identify an
  association, John Sweeny will remain the rep for this carry through period until such time as we can find a
  replacement

## 6. Air Services Update

RP introduced Paula McMahon and Ian McLeod to the committee, a brief overview of their roles was also provided.

 Paula acknowledged the committee for changing the meeting date to accommodate their attendance and provided the committee with background information regarding her division of Airservices Australia.

Airservices Australia (AA) is a statutory authority and all revenue is from industry.

- AA has several important principles, focusing on "safety" as priority number 1, then efficiency and the environment (which encompasses noise) coming third.
- AA has approximately 200 pieces of environmental legislation, ranging from Commonwealth to State, to comply
  with. The Airports Act 1996 and the Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act) are
  the primary sources of environmental legislation that apply.
- In 1999 there were a number of community service obligations under ministerial direction
- B Pinkstone would like it included in a letter, all the outstanding work M Simpkins has done over the years for the
  committee in his role as a proxy for N Hall, and if M Simpkins is successful in securing the position the ANACC
  committee would more than welcome him as a representative

#### 7. General Aviation Update

### Geoff North Update:

## GN discussed the Complaint from Mr Cutis

- GN and MS provided Mr Curtis with a tour of the Airservices Control Tower (Gold Coast). Mr Curtis gained a much better understanding of flight operations and was pleased with the result.
- GN highlighted the benefits of the Air Traffic Control Tower (ATC) tours and proposed that GCA facilitate a group tour for the ANACC committee.

Action: RP to discuss a plan for the group tour of the ATC with MS.

Resolution: It was agreed that the next ANACC meeting would be held at a venue on Gold Coast Airport to coincide with the ATC group tour.

## Light aircraft training

- Training is still going strong, weather permitting.
- P Long reported that Air Gold Coast is currently training about 60-70 pilots part time, half of which are recreational
  pilots.

Action: Australian Wings Academy to report back next meeting with their student numbers

- P Long pointed out the noise generated does vary depending on were the students are and what kind of training their doing, both Air Gold Coast and AWA try to keep to the training area above Murwillumbah, Stanthorpe or Casino when practising circuits, they are both very conscious of the noise and how to manage it better. Both schools are as proactive as ever with regards to the noise there students make.
- B Pinkstone said when the current tracks provided were reviewed it was documented in the report that the training
  academy's would be doing touch and goes in close proximity to the airport runway whether the over the sea or over
  the land. This regulation has been in place for years yet the community are finding they have a tendency to be
  flying out over the out lying areas which was never agreed to by the community.
- Airservices responded saying ideally what the training schools try to do is keep the circuit training as close to the
  airport as possible. Sometimes the training plan will be in the flight path of a jet and the training aircraft must move
  from there original flight path which causes them to hover above, inturn causing a lot more noise.
- Airservices also mentioned that due to the curfew of 2300 to 0600, there is constant aircraft movement and
  congestion throughout the day and this is what could be increasing noise issues. Currently there are no regulatory
  requirements or laws for light aircrafts it's just a matter of them doing the right thing.
- B Pinkstone said these are not one off incidents and if there going to be flying over the out lining areas there is a track that turns right at 1 DME and goes over the Terranora area
- John Sweeny said this recent period he has received the least amount of complaints since joining the ANACC committee and would like the thank Airservices for their tireless efforts

## 8. Military Operations

M Simpkins produced the military figures for the last 5 months. It is suspected a majority of these figures are related to the Globemaster Jets.

## **Jetstar RNP Operations**

 Tui advised committee that Jetstar are set to commence RNP operations, on a small number of departures, at Gold Coast Airport on the 7<sup>th</sup> September 2009.

There were no objections or opinions expressed in relation to this issue.

## Flights over Currumbin

- Wilf Ardill expressed his disappointment with the lack of a timely response, by relevant parties, to his complaint
  dated 22nd June 2009 regarding flights over Currumbin Hill, which was forwarded to Tui. Mr Ardill further
  highlighted that he would like to respond to complainants in a timely manner also but this prevented him from doing
  so.
- RP apologised and advised that Gold Coast Airport (GCA) have limited resources dedicated to the ANACC and that all GCA staff on the ANACC have day-to-day operational tasks they are committed to as well as ANACC.
- Paula McMahon mentioned that the Airservices Australia noise complaints line was a more appropriate course for Mr Ardill to take regarding the noise complaint.
- MS mentioned that Mr Ardill could contact him directly regarding noise complaints and that he is happy to liaise
