

# **Airport Noise Abatement Consultative Committee (ANACC)**Meeting Minutes

**Date:** Thursday 25<sup>th</sup> October 2018 **Time:** 0900 – 1200hrs (QLD Time) **Location:** Twin Towns Resort – Bay room

#### 1. Opening and Welcome

Chairman, Matt Bender, opened the meeting at 09.05 and welcomed members and observers to the October Meeting.

The Chair asked the Committee if there were any comments on the previous meeting minutes. The minutes were accepted by the committee with minor amendments.

#### 6. General Aviation Update

Peter Long was unable to attend, the Chair gave the committee an update on Peter's behalf. Since the helicopter operations have ceased, it is now GA operations are going steadily. Skydiving championships were held this month out of Southport aeroclub. Minor disruptions were reported and referred to Southport Aero Club.

## 7. Member Agenda Paper: Commissioning of the GCA ILS – John Hicks

#### Airservices Q&A

Neil presented on the ILS NAPs prior to answering John's questions from the agenda paper Attachment 4. A key point is that Air Traffic Control will nominate the ILS flight path when the height of cloud base is at or below approximately 800 feet and/or the visibility from the tower looking out along the ILS flight path at or below approximately 4 kilometres.

- **1.** Testing has not commenced, as the installation is still underway. Flight testing is pencilled in for the 8<sup>th</sup> December.
- **2.** By late 2018/early 2019 is the target operational availability. As soon as a date is set the committee will be notified.
- **3.** The testing aircraft will be a Beechcraft Super King Air operated by AeroPearl. There will be significant tests at different levels. Some tests will be at constant altitude and others will be at descending heights. When the test flights will occur, we will let the committee know.

- 4. There will be no RPT aircraft testing.
- **5.** A summary of the key aspects in the draft procedures was presented to the committee. Once the NAPs have been finalised they will be provided.
- **6.** Update to current ILS fact sheet on website, New ILS NAPS fact sheet on website, Newspaper notices in local newspapers together with a link to Airservices factsheet Gold Coast Bulletin and Gold Coast Sun, ANACC update including presentation, CACG update including presentation, DIRDC update, ANO update, Correspondence to Councillors and MPs in all overflown areas, Correspondence to schools and Gold Coast Hospital. There will also be notifications from Gold Coast Airport.

ANACC members noted that website postings are only suitable for people actively searching for information and that very few people read the public notices section of newspapers. ANACC members recommended that Airservices use media statements and mass media channels to draw people's attention to the imminent commissioning of the ILS.

- **7.** ANACC members are welcome to provide feedback on the procedures, or any suggestions. **ACTION:** Neil to send links to the website for committee feedback.
- **8.** Noise monitoring plans are yet to be determined. Once plans have been completed the committee will be notified.
- **9.** A post implementation review will be conducted 12-18 months when there is enough data for evidence.
- **10.** Airservices will report when NAPs are not complied with, the data is currently only tracked manually so we will have to come back to the committee on the detail of reporting. **ACTION:** Anthony to check on reporting capabilities.
- **11.** The data that Channel 7 presented was not provided by the airport at time of report, it was taken from the MDP. Diversion information is also difficult to confirm as not all diversions are resultant of a direct missed approach.

#### 8. Airservices Report

Neil provided an update on Airservices Actions, actions moving forward, flight path changes, RNP AR use and update. The presentation is attached to these minutes.

#### **Question/Discussion**

#### **RNAV Design Questions**

Query raised as to why the original flight path can't be replicated, it was indicated that it was unable to be accomplished due to CASA requirements.

## Fingal Head Noise Monitoring

Concerns were raised around the amount of data that came from the Fingal Head monitoring and the calibration of the equipment.

**ACTION:** As A to check the calibration of the monitor due to Banora Point levels being higher than Fingal and request additional data.

#### **Cudgen Hospital Development**

Concerns were raised around flight paths and noise over the new hospital, it was advised that Airservices were contacted and AsA advised that the development would be under the flight path. GCA indicated to the developer that helicopters would be a concern.

#### **Public Consultation**

Concerns were raised about the diagrams shown in public notices, as the corridor appears wider than the flight tracks. AsA advised that corridors were shown to indicate noise spread.

A query was raised that the new flight path will be intercepting over land and it will be contrary to the current NAPs. It was advised that in departure there may be more noise as opposed to arriving aircraft

**ACTION:** As A to provide a zoomed in map showing the intercept point.

Discussion around members concern around misleading data presented in the flight path changes, as only domestic flights were highlighted and only including current flight numbers not forecasted numbers. The Environmental Assessment was requested but was denied as the technical data could be misinterpreted and has been presented on previously.

## 9. Strategic Work Program

The topics covered at this meeting were:

- 2.1 Adherence to ILS flight path usage conditions. This was outlined in Airservices Presentation.
- 4.13 Too many international arrivals using the RWY 32 heading approach
   Deferred to next meeting as meeting running overtime.

## 10. DIRD Update

Russell McArthur presented the curfew report for June-September. Russell also provided an update on the status on Public Safety Areas, it is expected to be endorsed by the Transport Infrastructure Committee to take effect next year.

## 11. Confirmation of Strategic Work Program (SWP) topics for next meeting

The meeting agreed the following SWP topics would be the focus of the next meeting:

- 4.13 Too many international arrivals using the RWY 32 heading approach
- 4.11 Management of increasing RPT movements at GCA.

#### 12. General Business

The Chair advised for issues to be channelled into the ANACC meetings rather than the CACG meetings or the CACG Chair. Some issues may be necessary to raise at a CACG meeting due to timeframe issues.
